# 4-H BC Board President



In February the 4-H BC Conflict Managers attended Conflict Management training in Vancouver. For some it was a refresher and for others it was an opportunity to understand conflict; what causes conflict, how to manage conflict and methods for conflict resolution. In the spring, the 4-H BC office staff completed Standard First Aid training in preparation for the busy year ahead.

Discover 4-H Day Camps were held in Lake Country, Trail, Hudson Hope and Chetwynd during July. Our camp counsellors, Emily Beattie and April Marr, travelled the province providing a day of fun agricultural activities to youth aged 9-12 and connecting with communities allowing them an opportunity to become involved in the 4-H program.

Throughout the year several new fundraising opportunities were launched including; Peavey Mart Giving at the Till, National 4-H month Food Drive plus matching donations, Gord Bamford Concert Tickets and 'Making Futures Bright' 4-H BC Foundation Field of Clover campaign. Due to the efforts of Belinda Field, Fund Development Coordinator, with support from 4-H members, leaders, the community, 4-H BC Provincial Council, 4-H BC Foundation and 4-H BC staff, donations to 4-H BC Foundation have increased year over year.

In 2019 the Youth Development Programs Staff from the Ministry of Agriculture continued to collaborate with 4-H BC to help develop youth into agriculture community leaders. 2019 was an exciting year as the Ministry provided a second year of extra funding to 4-H BC to further grow farm safety programming for youth, support new clubs and volunteers, and increase outreach to potential new members from under-represented groups. A highlight this year was a new partnership with the Buy BC program to deliver the Buy BC Special Educational Display Program at the Pacific National Exhibition, and a new Buy BC social media contest for the 4-H BC Ambassador team.

In August, Lauren Bernardi joined the Youth Development team as a specialist based in Abbotsford. Jarrett Chung-Smith worked in Vernon as a Youth Development Specialist. Karla Barrie continued to work half time in Williams Lake as the Youth Development Assistant. We were also happy to have the support of Indigenous youth intern Marika Laird, and co-op

students Sarah Day and Jolene Schubert for parts of 2019. The whole Youth Development team worked diligently this year to deliver programs including Island 4-H Rendezvous, Peace River 4-H Showcase, 4-H Family Frenzy, the Ambassador Program, Agri-Career Quest, Youth Action, Provincial Communications Weekend, and 4-H Leader Training. We were also pleased to release updated educational materials to support the gardening, photography, and small engines projects.

Rita Pierson said, "Every child deserves a champion, an adult who will never give up on them, who understands the power of connection, and insists that they become the best that they can possibly be." The youth development team would like to thank all the 4-H BC leaders and volunteers for being that champion for the youth in their communities. It is a pleasure working alongside such a hardworking group of volunteers and families who are committed to positive youth development.





# **Youth Advisory Committee**

I started my term on the Youth Advisory Committee (YAC) representing BC in January 2020. In January there were 11 YAC representing their home provinces. Although, one YAC had to step down from his position as of February and the position has not been filled.

The YAC have started the second year of having a meeting structure with an executive. For 2020 our President is Logan (ON), Vice President is Eugenie (QC), and Secretary is McAuley (NL). # Regional Reports

#### **Central Interior** Heidi Meier

In 2019 the Central Interior Region consisted of 3 districts: Prince George with 4 clubs and 128 members; Quesnel having 4 clubs and 65 members; and Williams Lake with 8 clubs and 188 members; for a total of 381 members. Projects include Beef, Dairy, Swine, Sheep, Goat, Llama, Small Engines, Poultry, Photography, Cloverbud, Rabbits and Junior Leader.

Regional Communications were hosted by Williams Lake in May and Prince George hosted Family Frenzy for our members in September. Quesnel hosted an Ag Safety Day in June with approximately 80 participants. New leader training was offered in Williams Lake in February and in Prince George in September. Our large geographical area presents a challenge in offering regional events however, we do our best to offer programs for the region and rotate around the area.

The Quesnel district received grant funding from two sources which allowed them to purchase new penning, panels and dividers for their district show and sale. Their district also has members participate in a Club to Club exchange with a club from Manitoba.

Quesnel sent a senior demonstration team and Williams Lake sent a senior speaker to provincial communications.

Prince George held their annual dinner dance raising funds for new pens for their ever growing district.

It seems our region is growing with at least two new clubs for 2020. We are looking forward to a productive and successful 2020.

#### Fraser Valley Ginette Keglowitsch

The Fraser Valley 4-H Region is composed of five districts representing 30 clubs.

- North Fraser District 6 clubs
- Chilliwack District 6 clubs
- Langley District 6 clubs
- Surrey/Richmond/Delta District 3 clubs
- Abbotsford District 9 clubs

We have projects in Dog, Dairy, Beef, Swine, Llama, Small Engines, Robotics, Photography, Woolcraft, Sheep, Swine, Poultry, Gardening, Crafts, Cavy, Rabbit, Ambassador, Junior Leader, Self Determined, Foods, Outdoor Living, Tractor, Horse, Honeybee, Goat and Cloverbud. Most of our clubs run on a January – December club year.

Several of our districts received gaming grants to help with programming and promotional expenses.

Many of our clubs participated in the summer fairs, including Maple Ridge-Pitt Meadows Countryfest, Abbotsford AgriFair, Chilliwack Fair, PNE, IPE and Agassiz Fair.

All districts held judging rallies with the top judges going on to the competition at the PNE. North Fraser and Langley hold a joint rally to increase the numbers and reduce individual work loads. The members enjoy having the time with the neighbouring district.

Abbotsford District held a junior camp. Chilliwack District participated in an exchange.

Several districts held First Aid or Food Safe courses for members, leaders and parents.

We had four Ambassadors in the past year, two of whom have now completed their terms. Three will be continuing and we have four new incoming ambassadors. They are valuable resources for our clubs.

Our AgMent members are busy planning a regional judging workshop. There will be an emphasis on giving oral reasons for senior members.

District Awards Nights were held in October and November.

Our region had another successful 4-H to the Extreme on March 7 and is off to a busy start for 2020.

#### Kamloops-Okanagan Lorna Kotz

In 2019, the Kamloops-Okanagan Region had five district councils and 33 clubs. We cover a large area with more than 340km between the farthest clubs. This makes it challenging to get together as a whole region too often. Every year our districts take turns hosting regional events. In 2019, Kelowna hosted Regional Public speaking and Boundary District hosted Regional Demonstrations. We also held a Progressive Agriculture Regional Safety Day in Armstrong in October. We have decided to run this event in alternating years with Catch the Clover. As well, we have a regional record book competition that is very popular where we get to see some amazing books.

Each district has a full year of various events including camps, district communications, rally days and local safety days. Our region also hosts the Salmon Arm Summer Sizzler (for horse clubs) and the Okanagan 4-H Stock Show (Beef, Horse and Dog clubs) in the summer. As well our members look forward to attending the many fairs in our region.

In 2019 we lost our Regional treasurer. Joanna Hay had been a 4-H leader for many years and was involved with our Regional Council for several more. She will be sadly missed.

Overall, 2019 was a good year and we look forward to more 4-H in the future.

#### **Kootenay** Heather Serafini

The Kootenay Region consists of 5 clubs. There are 4 clubs in the Cranbrook District and one in the Creston District.

We start our year out with a Regional 4-H family camp. This is a fun filled weekend for all ages. It is a weekend that encourages leadership, team building and youth development as well as a lot of interaction with members from all over the region. A safety day was put on in October by our Safety coordinator, Tanya and the members learned so much about all types of safety and it was a very interactive day. Leaders had training in November to keep them up to date in their leadership roles.

In November our Beef program has its weigh in and our sheep and swine was in the beginning of February. March holds our Regional Public Speaking where members participate from both Districts. April looked at our 2nd Ag for All weekend. This weekend taught members and parents hands on techniques on suturing, injections, tractor safety, leg wraps, and treating bloat on the Saturday. On Sunday members were divided into three age groups and were taught how to groom their lamb, their beef animal and their swine. After this everyone was involved in showmanship classes that involved members, parents, and alumni. It was an amazing event for everyone involved.

Our Regional Judging Rally was held in May at Fort Steele Historical Park. Members did judging, dress review, educational displays and food displays. In June we held our Cranbrook and District Show and Sale and members from both Districts were involved. Market and showmanship classes were done in beef, sheep and swine. We had senior members attend provincial programming, PNE and communication finals.

Twelve of our members were fortunate enough to be able to go on a Club to Club Exchange with a Calf Club in Rocklyn, Ontario in July. Those members and their chaperones came back to BC in August. This was a great learning experience for our members.

Creston members travelled to the Maple Ridge fair to compete. They held their achievement day at the Creston Fall Fair in September.

We want to thank all of our members, leaders, alumni, sponsors, parents and everyone else that support us. Without the help we wouldn't be able to do what we do for our members.

#### Peace River Jody Watson

The Peace River Region consists of 2 Districts:

- South Peace District with 2 clubs: Groundbirch 4-H Club and Saddle Champs 4-H Club





# 4-H BC Foundation President

I am pleased to provide this 4-H British Columbia Foundation report for the fiscal year January 1st to December 31, 2019.

As 4-H BC Foundation becomes better known and understood by the 4-H community, 4-H alumni and friends of 4-H, new donors are coming on board to support 4-H youth in the future.

Foundation revenues have come from investments, 4-H Club assessments, donations, and fundraising. Total Foundation assets as of Dec 31, 2019 were \$1,560,740. Returns continue to be a result of a well-balanced investment policy and our investment advisors at CIBC Wood Gundy. Accumulated 2019 disbursements to 4-H BC Provincial Council were as follows: \$86,000 for ongoing Provincial 4-H Programs and services, \$15,980 for Designated Gift initiatives, and \$60,564 for the Extraordinary Funds (loan) initiative between 4-H BC Provincial Council and 4-H BC Foundation.

4-H BC Foundation continues to expand its mandate through Designated Gifts, whereby a donor directs the annual earnings from their donation to go to a specific 4-H program, 4-H region or 4-H district. The Foundation now administers four 4-H Endowments and two 4-H Designated Donations; a total of six Designated Gifts.

Together with 4-H BC Manager, Aleda Welch, and Fund Development Coordinator, Belinda Field, 4-H BC Foundation continues to move forward on fund development initiatives that fit within the 4-H BC Strategic Plan. Securing sustainable resources through an "integrated fund development and partnership strategy" is essential to meeting a strong and growing 4-H British Columbia vision of "Empowered and skilled young people committed to making positive change in their communities."

4-H BC Foundation continues to encourage Planned Legacy Giving from 4-H Alumni and supporters. I encourage all to consider a bequest through your will with wording, "I direct my Trustee to give to the 4-H British Columbia Foundation the sum of \$XXX from my estate." Everyone benefits from the power of a planned gift.... you, your family and 4-H as your charity of choice.

4-H BC Foundation continues to grow beyond being the "best kept 4-H secret going". 4-H Leaders and parents are encouraged to be passionate about your Foundation and make referrals of potential donors who express an interest in donations.
