
4-H BC Board President

2018 was filled with a variety of new initiatives and notable events for 4-H BC.

The year kicked off with the announcement that one of BC's own was being awarded a L.E.A.D. Scholarship at the 4-H Canada National Leadership Summit in Ottawa. This same member was chosen to represent 4-H Canada youth in Rome at the 45th session of the United Nations Committee on World Food Security. Not to be outdone, another 4-H BC member won the 4-H Canada Science Fair in Truro, NS with their impressive project "Safer Chick-ments". The winner of the Cariboo Chevrolet Buick GMS 4-H Award was yet another 4-H member chosen for her contributions to the 4-H community, mentoring younger 4-H members and dedication to agriculture in the province. These are just three examples of the many outstanding 4-H members in BC. We are extremely proud of all 4-H BC members, their accomplishments and the contributions that they make to their communities.

Through the generous support of BC Youth in Agriculture Foundation we were able to host Discover 4-H Day Camps throughout the summer. The day camps allowed us to introduce 4-H to communities in the province beyond the farm, reaching into more urban areas, while keeping connected to our agricultural roots.

Sadly, with the Rabbit Hemorrhagic Disease outbreak, 4-H rabbit shows and events had to be canceled. Thank you to all for following the biosecurity procedures that were put in place to reduce the spread of the disease and keeping our furry friends safe!

While visiting with Heather Serafini, 4-H BC Provincial Council President, and local 4-H youth in Cranbrook in September the Honorable Lana Popham, Minister of Agriculture, announced the BC Ministry of Agriculture's continued support of 4-H BC with an increase of \$63,000 over previous years. The additional funding was used to increase the internal capacity of 4-H BC Provincial Council in order to address important emerging needs such as comprehensive farm safety programming for youth, support for new clubs and volunteers, and outreach to potential new members from under-represented groups such as indigenous and urban youth.

There were many exciting things happening at the fall Provincial 4-H Leaders' Conference in Kamloops. 4-H BC announced our continued partnership with PrairieCoast Equipment who have once again donated 2 John Deere TX Gators to be prizes in the 2019 4-H BC Lottery. The Ralph and Mae Barichello Leadership Award was presented to Ellen Deglan. Congratulations Ellen! 4-H BC also hosted a full day of Key Leader training which was held simultaneously with the Progressive Agriculture Safety Training workshop.

Although there were some staff changes throughout the year, the level of service to the 4-H community and stakeholders remained strong. Belinda Field, Fund Development Coordinator, found her stride increasing Provincial partner contributions as well as donations to the 4-H BC Foundation. Our fresh new look for our website and promotional brochures was born from the creativity and expertise of our new Communications and Marketing Coordinator, Tracy Austin. I look forward to working with new team members Gwen Dell'Anno and Marie McGivern in the coming year.

In the end the success of 4-H BC is due to the dedication of members, volunteers and leaders. Through the commitment and leadership of 4-H BC Provincial Council and Foundation, the hard work and excellence of the 4-H BC office staff and our continued strong partnership with the Ministry of Agriculture, Youth Development Unit, 4-H BC will continue to be the youth program of choice.



2018 was a wonderful year of teamwork and collaboration with many members of the agricultural community.

4-H BC connects farming, leadership and youth in so many communities in B.C. Your programs provide safe places for young people to learn more about and prepare for many careers, including those in agriculture. Youth Development Programs Staff from the Ministry of Agriculture continue to work with 4-H BC to build leaders in agriculture and in our communities. 2018 was a very productive year as the Ministry provided additional funds to 4-H BC to augment farm safety programming for youth, support new clubs and volunteers, and increase outreach to potential new members from under-represented groups. 



As 4-H BC Foundation becomes better known and understood by the 4-H community, 4-H alumni and friends of 4-H, new donors are coming on board to support 4-H youth into the future.

Foundation revenues have come from investments, 4-H Club assessments, donations, and fundraising. Total Foundation assets as of Dec 31, 2018 were \$ 1,490,765. Returns continue to be a result of a well-balanced investment policy and our investment advisors at CIBC Wood Gundy. Accumulated 2018 disbursements to 4-H BC Provincial Council were as follows. \$73,782 for ongoing Provincial 4-H Programs and services, \$12,815 for Designated Gift initiatives and \$50,470 for the Extraordinary Funds initiative.

4-H BC Foundation continues to expand it's mandate through Designated Gifts, whereby a donor directs the annual earnings from their donation to go to a specific 4-H program or 4-H Region or 4-H District. In 2018 the Foundation received it's fourth 4-H Endowment to be known as the Nancy Loreth Memorial Scholarship, which will result in a new annual \$500 4-H Provincial Scholarship starting in 2019. Together with two 4-H Designated Donations, 4-H BC Foundation now administers six 4-H Designated Gifts.

Together with 4-H BC Manager, Aleda Welch, and Fund Development Coordinator, Belinda Field, 4-H BC Foundation is moving forward on fund development initiatives that fit with the 4-H BC Strategic Plan. Securing sustainable resources through an "integrated fund development and partnership strategy" is essential to meeting a strong and growing 4-H British Columbia vision of "Empowered and skilled young people committed to making positive change in their communities."

Thank you to contributors to the Field of Clover, and the first Online 4-H BC Auction. 4-H BC Foundation continues to encourage Planned Legacy Giving from 4-H Alumni and supporters. I encourage all to consider a bequest through your will with wording "I direct my Trustee to give to the 4-H British Columbia Foundation the sum of \$ _____ from my estate." Everyone benefits from the power of a planned gift.... you, your family and 4-H as your charity of choice.

4-H BC Foundation continues to grow beyond being the "best kept 4-H secret going." 4-H Leaders and parents are encouraged to be passionate about your Foundation and make referrals of potential donors who express an interest in donating. 
