

## REVIEW ENGAGEMENT REPORT

#### To the Directors of British Columbia 4-H Provincial Council

We have reviewed the balance sheet of British Columbia 4-H Provincial Council as at December 31, 2009 and the statements of earnings and changes in net assets and cash flows for the year then ended. Our review was made in accordance with Canadian generally accepted standards for review engagements and accordingly consisted primarily of enquiry, analytical procedures and discussion related to information supplied to us by the Council.

Adrienne and Shawne have prepared a Fund Development Work Plan for 2010 which has been approved by Council and the Foundation. This Plan will be the reference guide for Adrienne and Shawne for fund raising activities for 2010 and for promoting awareness and recognition of 4-H throughout B.C.

My thanks to the Trustees, Adrienne, Shawne and Kirsten for their commitment to B.C. 4-H and to Lorne for his cooperation throughout the year.
