2010 was filled with various new initiatives for B.C. 4-H, enhancing our program for the members, leaders and the communities in which we all live.

From the opening of the UBC 4-H Community Club to the new Good Food Lunch educational display program to the amalgamation of provincial public speaking and demonstrations, 2010 was a year of firsts for B.C. 4-H. The creation of a Vancouver based community club showed that the growth of 4-H is beyond the farm and is reaching into more urban areas, but keeping connected to our agricultural roots. The development of the Good Food Lunch educational display contest, had members looking at foods that were good to eat, good for kids, and good for B.C. farmers. As well as the educational display contest, members participated in a seminar about innovative product development. Provincial Communications Finals amalgamated provincial public speaking and provincial demonstrations to develop a more in depth program for delegates and continued to increase local agriculture awareness. In addition, in working with Parks Alive! Festivals Kelowna, the top performers returned to a local festival to present their speech and demonstration to an urban audience, again reaching 4-H into different communities.

Although there were some staff changes throughout the year, the level of service to the 4-H community and stakeholders stayed strong. With the support from the B.C. 4-H Foundation and the B.C. 4-H Provincial Council, the Fund Development Administrative Assistant position was created. With this support, B.C. 4-H was able to move forward with the Fund Development Work Plan by developing stronger relationships with sponsors, creating new campaigns for donors such as the Field of Clover; and make available funding opportunities for all levels of 4-H throughout the province. With one Platinum Clover Club sponsor, seven Silver Clover Club sponsors and two Bronze Clover Club sponsors, B.C. 4-H continued to provide exceptional opportunities to the members and leaders.

While attending the Provincial Communications Program in Kelowna, the Honorable Steve Thomson announced the BC Ministry of Agriculture and Lands continued support of B.C. 4-H with a grant of \$87,000. The support of the Ministry was confirmed with the signing of a 5 year Memorandum of Understanding. Although there were some internal changes within the Ministry of Agriculture, the Youth and Community Development unit continued to provide a high level of support to the 4-H community by producing numerous publications and presenting outstanding programs for our members and leaders.

At the fall Provincial 4-H Leader's Conference, B.C. 4-H announced our new partnership with Prairie Coast Equipment. The Interior and Coastal Region dealers have donated 2 John Deere GATORS as prizes for the 2011 B.C. 4-H Lottery.

The success of B.C. 4-H is determined by the involvement, commitment and dedication of members, volunteers and leaders; as well as the B.C. 4-H Provincial Council and Foundation, the B.C. 4-H office staff and our continued strong partnership with the Ministry of Agriculture, Youth Development Unit. Throughout 2010 the achievements of B.C. 4-H were attained because of the level of dedication to the 4-H movement throughout the province by all of these groups. Thank you to all of you for your ongoing support to develop our future agricultural leaders and strengthen the communities we are all a part of.

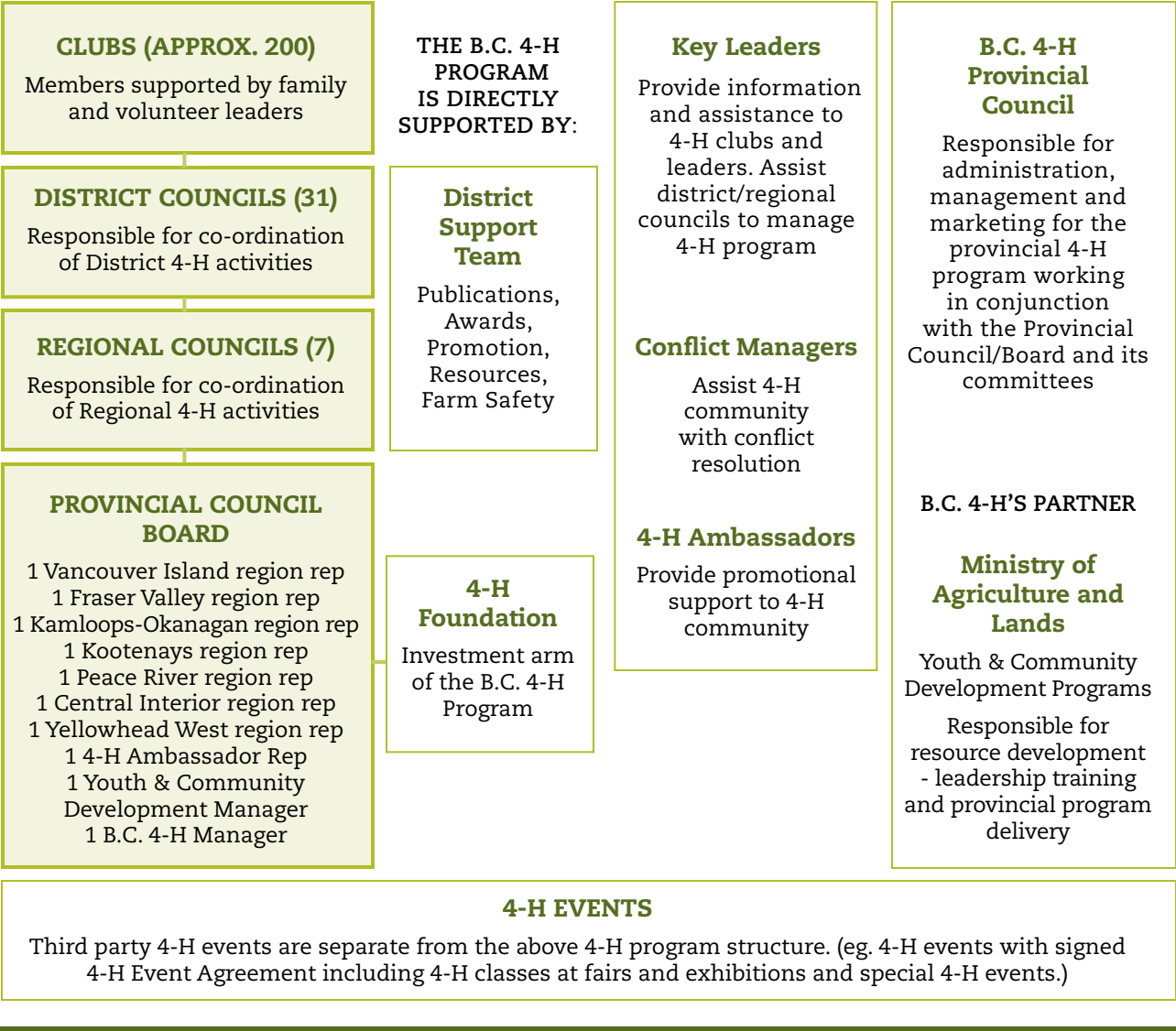

I am pleased to report that our Portfolio has weathered the storm of market fluctuations and, as the economy seems to be slowly regaining some of the momentum lost during the 2008 meltdown, we are optimistic that that recovery will continue through 2011.

For the fiscal year ending October 31, 2010 the annualized return on our investments was 15.3%. This compares very favourably with the average return of 5.877% generated over the past 3 years ending October 31, 2010. Because of the Market trauma of 2008, the three year average return as of October 31, 2008 was 0.33%. I think that this recovery can be attributed, in part, to the conservative approach taken in managing the account. The market value of the account as of October 31, 2009 was \$775,178.71 and as of October 31, 2010 it was \$831,824.34. A gain of \$56,645.63.

Our Fund Development program got under way with the Field of Clover campaign. It was well received and we expect that it will generate a good return to the Foundation. The campaign runs until April 15th, 2011. We also produced Foundation brochures, Planned Giving and Investment in Youth which can be used for promotional or as a mail-out which illustrates the different ways one can donate to the Foundation. The B.C. 4-H Lottery is another fund raising project. To meet our requirements and operate within the BC Lottery guidelines, this promotion will begin May 6th, 2011 and conclude November 5th, 2011.

Joan Bech, our Vice President, has retired to the Sunshine Coast and regretfully tendered her resignation. On behalf of the Foundation I would like to express our thanks and appreciation to Joan for her many years of service and dedication, not only to the Foundation, but also for her commitment and generosity in serving 4-H in British Columbia. We express our thanks to Joan and at the same time extend a warm welcome to Brian Baehr who replaces Joan on the Foundation for 2011. Brian brings a wealth of experience both in 4-H and in the agricultural industry.

The addition of Gwen Tomra and Brandi Shane to our staff gives us a full staff complement for the first time in years - a warm welcome to Gwen and Brandi to the 4-H team. I extend my thanks to the Trustees, Adrienne and Shawne for their support and commitment throughout the year.
