












The ambassador team had an excellent year in 2011. 16 of the 17 ambassadors completed their achievement requirements with many going above and beyond what was required.



It has been a privilege to serve as your President for the past six years. During that time we have had many changes and challenges to navigate. The reorganization of the Provincial Council, the restructuring of the Foundation and the upheaval in the world markets were significant issues with which we had to deal. I am pleased to report that we managed those changes very well. There is now a better dialogue and understanding

between the Provincial Council and the Foundation and our Portfolio reflects a steady growth, notwithstanding the continuing turmoil in the world markets.

The addition of Shawne Bremer to our Team as our Fund Development Coordinator is a success story. Our donations to the end of our fiscal year totalled \$11,984.00. Of this amount, \$5,691.00 was generated by the Field of Clover Promotion and \$6,293.00 was donated to the General Fund. The B.C. 4-H Lottery was a major success. All clubs participated and of the 8,000 tickets issued, we sold 92.31% which realized a gross return of \$22,590.00, less lottery expenses there was a net return of \$21,954.00 which was shared equally between Provincial Council and the Foundation.

Both the Foundation and the Provincial Council are in agreement that we must continue to raise the profile of B.C. 4-H not only across the Province but within the Agricultural community specifically. Adrienne and her team continue to explore every opportunity to put this plan into effect. We are seeing the results of these efforts.

I close with thanks to the Trustees of the Foundation, Adrienne and her staff and to Susy Chung-Smith for their cooperation and support this past year. These are exciting times for 4-H in B.C. I am convinced that the years ahead, while challenging, will prove to be most rewarding.
