


B.C. 4-H Structure

I am pleased to provide this B.C. 4-H Foundation report for the fiscal year Nov 1, 2012 to Oct 31, 2013. Foundation awareness is key to supporting ongoing Foundation donations.

Foundation revenues for the fiscal year totaled \$82,420, generated from the interest and dividends, 4-H Club membership assessment, donations, fundraising and contributions. This year's Prairie Coast John Deere Gator Lottery will result in an additional \$9,000 donation to the Foundation in upcoming fiscal year. Total Foundation assets as of Oct 31, 2013 are \$1,108,712.

Investment returns continue to be a result of the Foundation's well balanced investment policy and good advice from our investment advisors at National Bank.

Foundation investments provided \$40,000 to B.C.4-H Provincial Council for provincial 4-H programs.

A highlight of the year was the opportunity for Susy Chung, Past B.C. 4-H President; Barry Remus and myself to enjoy a working lunch with B.C. Lieutenant-Governor Judith Guichon, at Government House. Her Honour is very interested in promoting B.C. agriculture, youth and rural communities. As a past 4-H leader, and with her extended family involved, she has a special interest in 4-H. B.C.
