The benefits of legacy giving are immediate and farreaching. Legacy giving, is in essence, deciding in advance what happens to your estate. It puts you in control. Whether its cash, securities, life insurance, real estate or gifts-in-kind, a well-planned gift ensures your legacy makes a statement.

4-H is considered by some to be Canada's premier youth development organization. Now, more than ever, it is vital that we provide accessibility to programming that connects our young people with agriculture and food production, and helps them to maintain a strong sense of our rural roots. A legacy gift to the 4-H BC Foundation is a gift to the future leaders of the communities in which we live, work and play. Legacy giving can also deliver significant advantages to you and your heirs including:

- Satisfaction Knowing that you are giving back to an organization that holds special significance for you.
- **Control** Reducing the risk that your wishes will be hindered by circumstances beyond your control.
- **Peace of Mind** Ensuring that family and financial matters are resolved privately.
- Convenience Putting your investment in the hands of professional managers, so you don't have to worry about ongoing decisions.
- Security Finalizing your charitable choices now, instead of later or never. Too many people postpone their wishes or never realize them.
- Financial Lowering your current taxes and/or lowering the taxes your estate will be required to pay by making donations to a registered charitable organization such as the 4-H BC Foundation. These decisions should be discussed with an accountant, lawyer or financial advisor prior to proceeding with any major donations.



Everyone benefits from the power of a legacy gift - you, your family and your charity of choice. Of course, we want to ensure that each of these groups receives the maximum benefit possible. This is why your financial investment professional can advise you in selecting from a wide range of legacy giving arrangements.



BEQUESTS

The 4-H BC Foundation can accept, and provide charitable receipts for, both cash bequests and gifts-in-kind through your will. A simple statement (as seen below), is often enough.

"I direct my Trustee to give to the 4-H BC Foundation the sum of \$ ——from my estate."

OR

"I direct my Trustee to give to the 4-H BC Foundation ____ % of the residual value of my estate, after all expenses and specific bequests have been deducted."

LIFE INSURANCE POLICY

Small annual installments can mean a substantial gift for 4-H, plus your estate is not affected and the gift is not diminished due to taxes, probate or administration fees. Choose to donate with an existing policy, or a new one by naming the 4-H BC Foundation as the beneficiary of your Life Insurance Policy and realize tax savings today as well as to your estate.

CHARITABLE REMAINDER OF TRUST (CRT)

A CRT is an irrevocable trust that provides income for two sets of beneficiaries: you and the 4-H organization. You receive income for a specified period (or for life) from the trust. The 4-H BC Foundation then receives the balance of the principal of the trust once that period ends.

GIFTS IN-KIND

The 4-H BC Foundation is also able to accept donations of real property such as stocks, bonds, artwork, houses, land, books and other assets. Gifts in-kind may be made as outright gifts, through a will or trust and also have tax benefits.

RRSPs/RIFs

This is the best option for those that like the simple process of designating 4-H BC Foundation as a beneficiary via a form and allows the gift to get to the charity quickly since it passes outside the estate.

REAL ESTATE

Perhaps not the traditional way of giving, but a very effective one. Land or buildings, commercial or private, make excellent charitable gifts. The property can either be used by the organization, leased or sold, with the proceeds used for purposes designated by the donor.

IN HONOUR

"In honour of donations" recognize a birthday, anniversary, achievement, or any other gift giving opportunity.

MEMORIAMS

"In memoriam" donations can be made to the 4-H BC Foundation in memory of someone special who has enjoyed a lifetime involved in agriculture, been supportive of 4-H or of youth in general.
